01/02/2003	<p>“She’s the Best There Is”</p> <p>Ric suggests that Alexis should be Jason’s attorney. Sonny tells him she wouldn’t do it. Zander discovers Ned’s connection to Faith. Brenda and Jason plead innocent in court. Jason fires his attorney and reluctantly hires Ric. Gia gets Ida’s statement on tape illegally.</p>
01/03/2003	<p>“Have You Ever Heard of Witness Tampering?”</p> <p>Gia and and Nikolas show Alexis the tape of Ida. She is livid. Ric finds Ida hanging dead at the safe house. Ric tells Alexis about Ida’s suicide. Carly overhears Jax telling Alexis to let Scott nail Jason so Brenda can go free.</p>
01/06/2003	<p>“Wrong Place At The Wrong Time With The Wrong Man”</p> <p>Carly slaps Alexis in the courtroom. Cameron plays poker with Luke. Alexis falls asleep in the courtroom and dreams that Kristina tells her to avenge her death by going after Jason. Cameron wakes Alexis from her dream. Jax arrives and tells Cameron he wants him to prove that Brenda is crazy.</p>
01/07/2003	<p>“He’s Not The Father”</p> <p>Alexis sees Ned and Faith having sex on the docks. Cameron speaks with Brenda and Jax and tells them he’ll evaluate Brenda’s condition. Cameron finds Alexis outside of Kelly’s crying. She lets it slip that Ned isn’t the father. Cameron tells Alexis that his younger son killed his older son in a hunting accident. We find out that Zander is his son.</p>
01/08/2003	<p>“Hypnosis”</p> <p>Brenda asks Cameron to hypnotize her so that she can remember all of the details about the murder. Brenda remembers seeing Ric in the hallway outside Alcazar’s room.</p>
01/09/2003	<p>“Pompous, Condescending Misogynist”</p> <p>Ric interrupts the hypnotism session but it later continues without Brenda realizing the man she saw was Ric. Later, Alexis asks Cameron if it’s possible for someone to just snap. She asks Cameron about his youngest son. He tells her about changing careers, losing his marriage and hiring a detective to look for Alexander. They end up arguing about Ned. Zander delivers an envelope from Ned which prompts Alexis to pay a visit to Faith Rosco. Ned steps out of Faith’s bathroom in just a towel.</p>
01/10/2003	<p>“What on Earth Has Happened To You?”</p> <p>Alexis tells Ned she doesn’t need his financial support for Kristina and she feels threatened by his paying for her medical bills. She tells him she doesn’t want him to see Kristina anymore and threatens to take him to family court. Cameron finds Alexis outside Kelly’s again. She tells him that Ned is trying to take Kristina away from her. Zander sees Cameron through Kelly’s window.</p>
01/13/2003	<p>“Why Are You Threatening Me?”</p> <p>Alexis asks the doctor not to allow Ned to visit Kristina anymore. Cameron argues with her for doing so. Sonny tells Ric that he knows his connection to Alcazar. Ric admits he wanted to kill Alcazar. Ned threatens to tell Sonny about Kristina if Alexis doesn’t allow Ned to see her. Zander remembers Pete’s death.</p>

01/14/2003	<p>“I Don’t Like Being Threatened”</p> <p>A high Zander goes to Faith’s and propositions her. She gives him money to trash Carly’s club. He remembers back to his conversation with Cameron after Pete’s funeral. Alexis tells Brenda not to tell the police she saw Ric at the hotel. At Kelly’s, Alexis tells Cameron that she was coerced into letting Ned see Kristina. Ric is brought to the PCPD for questioning.</p>
01/15/2003	<p>“You’ll Do The Right Thing – You Always Do”</p> <p>Alexis tries to get a continuance for Brenda and Jason’s trial. Taggart tells her she won’t get one as long as Scott is on the case. At the PCPD, Sonny asks Alexis to represent Jason. Scott taunts Alexis at the courthouse by telling her she does whatever Sonny wants. As the trial begins, Jason arrives late and Brenda is missing.</p>
01/16/2003	<p>“Is This a Setup?”</p> <p>Brenda is found in the lake after diving down to Luis’ sunken yacht to retrieve a safe deposit box key. She gives it to Jax after she’s brought to the hospital. Zander is arrested. Alexis asks Jason if he and Sonny are up to something. Zander and Cameron come face to face at the PCPD. Alexis appeals to the judge to delay the trial while Brenda is in the hospital. He refuses. Jax retrieves a video tape from Alcazar’s safe deposit box and hands it over to the police instead of Sonny.</p>
01/17/2003	<p>“It’s Over”</p> <p>Zander and Cameron have angry words at the PCPD. Cameron says he wished Zander was the one that died – not Peter. Alexis tries to make the tape inadmissible in court but can’t. The trial continues with a live video feed from Brenda’s hospital room. Alexis destroys A.J. and Skye on the stand. The tape is played revealing Brenda’s prior attack of Alcazar.</p>
01/20/2003	<p>“I’m Asking You to Save Her Life”</p> <p>Gia tells Cameron about all the trouble Zander has gotten into since arriving in Port Charles. Alexis begs Jason to take the stand to clear Brenda. Brenda escapes from the hospital so she can leave town with Jax and Jason. Zander O.D.s and is brought to the hospital.</p>
01/21/2003	<p>“What It Means To Put Your Family First”</p> <p>Cameron tells Zander he’s being a coward by O.D.ing. Alexis goes to Sonny’s and resigns from the case so that she can take Kristina to Johns Hopkins for elective surgery. Ned and Cameron are surprised to find out Alexis took Kristina out of the hospital. Cameron tells Ned to cut Alexis some slack. Ned tells him she’s pushing him so he’s going to start pushing back. Zander confides in Gia and Nikolas isn’t happy about it. Jason tells Brenda he isn’t leaving.</p>
01/22/2003	<p>“Are We Father and Son – Or Nothing?”</p> <p>Cameron tells Zander nothing can sever the ties between a father and son – not even death. Cameron defends Zander when Nikolas talks him down to Gia.</p>
01/23/2003	<p>“They’re Innocent. I Have Proof”</p> <p>Ric gets a message written in lipstick on his mirror. Dara takes Jason and Brenda’s case after Alexis resigns. Zander tells Ned that his father is in town and that’s why he O.D.’d. He also tells him that Faith paid him to trash Carly’s place and told him not to tell Ned. Felicia tries to find out who paid off Ida. The tape of Ida’s statement is played in court. Scotty destroys Brenda on the stand.</p>

01/24/2003	<p>“I’m The Killer”</p> <p>A woman claiming to be the killer lures Ric to the docks and confesses. The trial ends with Jason and Brenda found guilty.</p>
01/27/2003	<p>“Of Swatches and Stomach Wounds”</p> <p>Ric tells Dara and Felicia about his meeting on the docks. He and Felicia take the swatch of cloth with the blood evidence on it to Scotty. The killer calls Scott’s office while they are all there.</p>
01/28/2003	<p>“A Clubhouse for Amateur Detectives”</p> <p>Ric tells Felicia and Dara about the mystery woman. Felicia and Ric bring the swatch of cloth to Scott and Taggart.</p>
01/29/2003	<p>“Vacate the Judgment”</p> <p>Alexis is back in town and takes over the case from Dara. The judge grants Alexis’ petition to vacate the guilty verdict in lieu of the new evidence. Cameron and Zander have an argument at Luke’s Club. After Zander leaves Cameron tells Luke about his relationship with Zander and Pete.</p>
01/30/2003	<p>“Wind Chimes”</p> <p>Cameron arrives at Alexis’ place and hears her scream inside. He kicks down the door and finds her awakening from a nightmare. There are wind chimes on her coffee table. When Cameron questions her about them she says she doesn’t remember buying them. Cameron talks to Ned about her behavior. Ned says that Alexis is a remarkably strong person considering her awful childhood. Scotty asks Alexis to come to the police department. He asks her who she thinks the murderer is.</p>
01/31/2003	<p>“Alexis Doesn’t Live Here Anymore”</p> <p>Cameron finds Alexis at the hospital holding Kristina and totally zoned out. She doesn’t remember arriving at the hospital. She writes it off as stress. Cameron later follows her to Kristina’s grave and then back to her apartment. Packages arrive for her from Wyndham’s and we see her dress up like her sister Kristina as Cameron knocks on the door.</p>
02/03/2003	<p>“Zander Is Your Son?”</p> <p>Alexis, in a red “Kristina” wig is interrupted by Cameron at her door. She quickly changes her clothes and answers the door. She says she was about to take shower. He waits for her and then tells her he followed her during the day. He wants her to tell him where she’s been. She tells him she was at Kristina’s grave. He says that if she doesn’t go out to dinner with him he’ll keep following her. Later on the docks Cameron asks Alexis what Kristina was like. They are interrupted by Zander. Alexis is shocked to hear that Zander is Cameron’s son. She tells him he should work on his own family before he goes prying into hers. Later, Alexis appears on the docks in the red wig. Ned catches a glimpse of her.</p>

02/04/2003	<p>"Whoever Did That Should Be Praised, Not Prosecuted"</p> <p>Ned goes to Kelly's and asks Liz if a red-headed woman has been there. Cameron overhears the conversation and asked what the woman looked like. Ned takes out a picture of Kristina. Alexis waits for Ned to leave and then walks into Kelly's. She and Cameron talk about grief. When he asks her if she ever finds herself trying to be like Kristina she gets aggravated. In the mean time, Skye goes to Alcazar's suite and suddenly remembers seeing a woman come off the balcony and leave the room. Scott and Taggart try to arrest her for the murder but she runs out onto the balcony and threatens to jump. Jax, Cameron and Alexis arrive.</p>
02/05/2003	<p>"Is This Some Weird Pickup Line?"</p> <p>Jax coaxes Skye off the balcony and Alexis agrees to be her lawyer. Alexis goes out onto the balcony and seems to drift off. Cameron says he think she's hiding something. Alexis speaks with Skye at the PCPD and Skye seems to suddenly remember something and becomes frightened. Cameron hangs around Alexis after Jax takes Skye out.</p>
02/06/2003	<p>No advance in storyline</p>
02/07/2003	<p>"Hello Kristina. I've Been Waiting to Meet You"</p> <p>Alexis has breakfast at Kelly's where she learns that Bobbie has begun to stock a special tea she's been requesting. When she drinks it Alexis thinks it's terrible. Cameron offers his tea and soon after Faith and Ned walk it. Alexis causes a scene and Ned and Faith leave. Cameron questions her about her behavior and then follows her when she leaves. She overhears Ned and Faith talking about her . She puts on the wig and Cameron catches her.</p>
02/10/2003	<p>"What's Happening To Me?"</p> <p>Cameron confronts Alexis on the docks and reveals to her that she's wearing a red wig. He tells her he wants her to have some tests including an MRI. She's worried she's got a brain tumor. Later at the hospital Cameron reassures her that she's not alone. He tells her that her symptoms are that of multiple personality disorder. Alexis thinks he's nuts. Skye meets her at the hospital to go over her case. She suddenly remembers seeing Alexis at Alcazar's hotel the night of the murder.</p>
02/11/2003	<p>"I Think My Lawyer Is The Killer"</p> <p>Skye is very uncomfortable speaking with Alexis so she leaves her under the guise of going to an A.A. meeting. Later at Kelly's Skye tells Felicia she's sure that Alexis was at the hotel when Alcazar was murdered. Cameron tells Alexis that her medical tests turned up negative for any tumors. He says her behavior is due to a dissociative defense mechanism. She isn't willing to listen. Felicia tells Cameron what Skye had to say. Cameron asks Felicia to slow down her investigation until he can figure out what's going on with Alexis.</p>
02/12/2003	<p>"Toxins"</p> <p>Alexis meets Cameron at the gatehouse where he asks her about her sister and her mother. She lapses into "Kristina" and says that she protects Alexis. When "Alexis" returns she is confused and throws Cameron out.</p>

02/13/2003	“Let Me Have My Little Girl” Alexis goes to the hospital to bring baby Kristina home but Bobbie tells her the doctor won’t release her yet. Alexis asks which doctor – it was Cameron. Alexis goes in and out of “Kristina” mode and threatens Cameron if he doesn’t let her take the baby home.
02/14/2003	“I Admit It. I Killed Him.” Alexis as Kristina tries to hit on Ned at Jax’s wedding. Cameron steps in and takes her away to the docks where she admits to killing Alcazar. She says she stabbed him and she was the one that met Ric on the docks. She then pulls a knife on Cameron and tells him if he doesn’t keep the secret she’ll kill him.
02/17/2003	“Please Don’t Let Me Lose My Baby” Camis docks scenes. Cameron wrestles “Kristina” and she backs down with the knife. When “Alexis” returns she begs Cameron not to tell anyone that she committed the murder. She says she’s an excellent attorney and can get anyone off a murder charge. He tells her he’ll make sure she doesn’t lose her baby or her mind and hugs her as she sobs.
