02/20/2003	<p>“Who Will Protect Her”</p> <p>Cameron meets up with Alexis at the nurses’ desk. She’s afraid to be with Kristina alone in case her alter emerges. Cameron says he’ll go with her. Skye tells Jax that the woman she saw was Alexis. Scotty hears the conversation via a planted listening device on Skye’s coat. Jax goes to speak to Alexis and “Kristina” emerges and throws him and Cameron out of her apartment. Cameron lets Jax know what’s going on. They both vow to protect Alexis.</p>
02/21/2003	<p>“I Did It To Protect My Sister”</p> <p>Alexis reemerges from “Kristina”. She tells Cameron she’s afraid and he hugs her. Scott arrives at her apartment later to try to get her to talk about the murder. She threatens him with a letter opener. Taggart is at the hospital and overhears Cameron telling another doctor he’s having Alexis committed.</p>
02/24/2003	<p>“Don’t Cry”</p> <p>Cameron arrives at Alexis’ just as “Kristina” is threatening Scott with a knife. Alexis appears to reemerge and Cameron tells Scott what is happening to her. Alexis agrees that she must be arrested. In the mean time, Jax has convinced Skye stall long enough to help Alexis. Taggart and Scott take Alexis to the hospital in handcuffs. They allow her to visit the baby before she is taken to the psych ward.</p>
02/25/2003	<p>“I’m Afraid I’m All Tied Up”</p> <p>Alexis flips into Kristina when first put into restraints in the psych ward. Cameron throws everyone out of the room and does the job himself – successfully. Taggart tells Ned, Skye and Jax about Alexis’ arrest. They go to the hospital. Jax tells Alexis he’ll make sure she never goes to jail. Alexis is unsettled when Faith walks into her room holding baby Kristina.</p>
02/26/2003	<p>Fan February Episode</p> <p>Sonny is trying to get into heaven. But first he must visit Alexis. She tells him Kristina is his daughter.</p>
02/27/2003	<p>“I Don’t Plan on Spending One Night in Jail”</p> <p>Scotty pays Alexis a visits and tell she won’t succeed in pleading insanity. He says she’ll be in the nuthouse for life. Cameron shoos him away. Alexis tells Cameron she’s afraid Kristina will grow up without her. Cameron takes her hand and tells her he’ll make sure that doesn’t happen. Ned pays a visit and says he wants to take Kristina home. Later Cameron comes back and Alexis tells him that Ned wants to take Kristina away. He tells her she has to concentrate on her therapy. He tells her that he’s testified in DID cases before and he’ll make sure she gets the minimum sentence.</p>
02/28/2003	<p>“From Attorney At Law to Lunatic Spectacle”</p> <p>Cameron video tapes Alexis and manages to provoke Kristina into emerging. She confesses to Alkazar’s murder. Cameron immediately brings the tape to the PCPD. While there he has opportunity to look in a box of files confiscated from Alexis’ apartment. On top of the pile are Alexis’ notes regarding D.I.D. insanity defenses. Cameron is stunned by his find. He returns to the hospital and tells Alexis he has researched precedent cases for her. She claims not to be familiar with them.</p>

03/03/2003	<p>“One Colossal Snow Job” Cameron confronts Alexis she admits to faking insanity. She tells him what happened the night of the murder and explains that the murder was self-defense. She begs Cameron not to tell. He is angry and says that she used him. He tells her he’s going to tell Scott. Meanwhile, Scotty has decided that Alexis is faking. When Cameron arrives he tells Scott that Alexis is clearly unstable and he shouldn’t spend the taxpayers’ money on a trial. (This is also the “Hush Little Baby” episode)</p>
03/04/2003	<p>“Take Good Care of My Baby” Cameron tells Alexis that he covered for her. She’s grateful and wonders why he’s helping her. He feels that if he helps her keep her baby somehow he can mend his relationship with Zander. Ned comes and Alexis agrees to let him take Kristina home to the gatehouse. Cameron asks for Gia’s help getting information from Taggart. Taggart tells her Scott thinks Alexis is faking D.I.D. Jax visits Alexis and tells her he’s got a lawyer for her. Gia come and tells Cameron and Alexis what she found out from her brother.</p>
03/05/2003	No advance in storyline ☹
03/06/2003	<p>“Scott Takes the Heat” The mayor makes it clear he isn’t happy about how Scott has handled the Alcazar murder case</p>
03/07/2003	No advance in storyline ☹
03/11/2003	<p>“Hello My Love” Cameron takes Alexis to the gatehouse to visit Kristina. Ned is surprised to find them when he comes home.</p>
03/12/2003	<p>“I Didn’t Trust the Wrong Person, Did I?” Edward goes to see Alexis and tells her she’s a danger to her child. Cameron intercedes. Scott tries to get Zander to tell him the details of her case. Later Zander goes to visit Alexis and tells her she shouldn’t trust his father because when the going gets tough he bails. Cameron assures her he won’t.</p>
03/13/2003	<p>“I Fooled You, Didn’t I?” Alexis’ first day in court. Scott calls Cameron to the stand and tries to get him to say Alexis is faking. Dara calls Ned and Scott to the stand for Alexis. Finally she calls Alexis to the stand and provokes “Kristina” to emerge.</p>
03/14/2003	<p>“You Bastard!” Alexis attacks Scott in court but ends up stabbing Cameron in the process. Scott, with the help of Edward, manages to get Alexis to make an error on the stand which implies she could be faking her disorder. After the closing arguments the judge says she’s rendered her decision and requires no further deliberation.</p>
03/17/2003	<p>“Not Guilty By Reason of Temporary Insanity” Alexis gets her verdict – she’s free but she loses custody of Kristina for six months. She gets to have one last goodbye in the courtroom. Ned is shocked that he’s suddenly a full time dad. Zander sees that his dad can be a very caring person. Cameron comforts Alexis and later takes her home.</p>

03/18/2003	<p>“Goal-Oriented and Extremely Competitive”</p> <p>Alexis tells Cameron about her plan to be “cured” in 6 weeks so that she can be reunited with Kristina. Cameron tells her it won’t be that easy and she has to accept reality. Jax visits Alexis who tells him her plan to see Kristina with his help. He declines. In desperation she goes to the gatehouse to see if Ned will let her see the baby. He throws her out.</p>
03/19/2003	No advance in storyline ☹
03/20/2003	GH preempted due to Iraq war
03/21/2003	GH preempted due to Iraq war
03/24/2003	<p>“Gatehouse Fire”</p> <p>Zander saves Ned from the fire. Alexis arrives on the scene and is frantic to find Kristina. She rushes to the mansion. Zander and Ned are taken to the hospital. Cameron attends to Zander. Alexis finds Alan holding Kristina and convinces him to let her hold the baby. She does but Edward and Scotty arrive and spoil the party. Later Alexis arrives at the hospital and fights with Ned in the emergency room on live television.</p>
03/25/2003	<p>“Go To Hell, Edward”</p> <p>Alexis sees news of the fire on TV and races to the scene. Zander rescues Ned from the fire and both are taken to the hospital. Alexis finds Kristina with Alan at the mansion and Alan reluctantly allows Alexis to hold the baby. Scott and Edward show up and have Alan take the baby away. At the hospital, Cameron treats Zander and then tries to get a very angry Alexis to calm down as she screams at Ned in the E.R. on live TV.</p>
03/26/2003	<p>“You Never Fight For Anything!”</p> <p>Alexis yells at Ned for leaving the baby with the nanny. Gia and Zander go to the fire scene and determine that it was arson and Scott has something to do with it. Skye and Monica figure out the ruse the Q men put together. Judge Farmer awards custody of Kristina to Edward.</p>
03/27/2003	<p>“I’m Going to See Kristina’s Father”</p> <p>Monica tells the Q boys that she’ll foil their plan by handing Kristina over to the court for foster care. She ends up changing her mind, however, when Big Alice suggests foster care would be a bad idea. Alexis leaves her therapy session with Cameron hot on her trail. She tells him the Qs are treacherous and has to get Kristina away from them. She tells Cameron she’s going to see Kristina’s father.</p>
03/28/2003	<p>“Now Your Hands Aren’t Clean, Are They?”</p> <p>Cameron races to the Q’s to warn Ned that Alexis is going to see Kristina’s father. Alexis goes to see Sonny. He tells her she should thank god that he’s not Kristina’s father. She asks for his help but he refuses. She leaves in tears and runs into Ned outside the Towers. He tells her that the fire was Edward’s plan to get Kristina. Alexis tells Ned she can’t trust anybody. She ends up at the Quartermaines’ watching them coo over Kristina through the windows.</p>
