<a href="#">10/01/2003</a>	<p><b>“Pitch A Tent In The Woods”</b></p> <p>Alexis released on bail and Dara tells her it was Cameron that bailed her out. Alexis goes to visit Kristina at the cottage and Cameron is there. He gives her loan papers to pay him back for the bail money. He wants to charge her too much in interest and she objects. She then tells him he should move into her apartment so she can be with the baby. They argue about visitation, the loan and the apartment before going up to see the baby. When they come down they’ve reached a compromise – he’ll move into her place and charge her half the interest he planned. Luke arrives and asks for Alexis’ help.</p>
<a href="#">10/02/2003</a>	<p><b>“Champagne and Faux Fondue”</b></p> <p>Luke summons Alexis, Nikolas, Zander and Emily to a warehouse on the docks where he has prepared a mock courtroom. He has set up a video camera and satellite dish by which to broadcast Stefan’s “trial” over live TV. When the group assembles, Luke comes in with Stefan, whom he’s kidnapped for the occasion.</p>
<a href="#">10/03/2003</a>	<p><b>“Coming At You Live”</b></p> <p>Luke begins his trial. Stefan starts off the proceedings by claiming his innocence. But “testimonies” by Nikolas, Emily, Lydia and Alexis all appear to prove Stefan’s guilt. As the citizens of Port Charles look on, Stefan ultimately confesses to being responsible for Summer’s death in an attempt to have Emily killed.</p>
<a href="#">10/06/2003</a>	<p><b>“The Penalty Phase”</b></p> <p>Luke declares Stefan guilty of murder and drags him off to the PCPD. Stefan gets off on a technicality and Scott arrests Luke for kidnapping. Alexis bails him out of jail. Stefan, in the mean time, is visited by Capelli wielding a gun. A fight ensues resulting in Stefan being burned by a fire gone out of control at Wyndemere.</p>
<a href="#">10/07/2003</a>	<p><b>“Moo-ving Day”</b></p> <p>While Alexis and Zander talk, Cameron arrives at Alexis’ apartment with Kristina and a noisy toy. Zander teases his father about wanting to move in with Alexis all along. Later, Alexis is distracted by the constant noise of Kristina’s toy and picks a fight with Cameron. Meanwhile, Stefan is visited by Lorenzo and Luke as his bedside.</p>
<a href="#">10/08/2003</a>	<p><b>“Zander Meets With Cindy”</b> (No Alexis or Cameron in this episode)</p> <p>Zander tries to get information that Alexis can use. He finds out that Cindy will continue to receive money even if Alexis goes to jail. Emily isn’t happy that Zander is helping Alexis. He tells her he owes Alexis a lot for keeping him out of jail. Meanwhile, Stefan tells Lydia that if she bears <i>his</i> child she can pass it off as Nikolas’ and still get the inheritance to save the Cassadines.</p>
<a href="#">10/09/2003</a>	<p><b>“I Deserve Better”</b> (No Alexis or Cameron in this episode)</p> <p>Zander tells Emily their marriage is over</p>
<a href="#">10/10/2003</a>	<p><b>“Now Your Life Is Over Too”</b> (No Alexis or Cameron in this episode)</p> <p>Lydia agrees to bear Stefan’s child. Luke arrives and he and Stefan struggle for a knife. Lucky interrupts their battle and Stefan gets away. Luke later finds him. They struggle before Stefan allows Luke to stab him. Luke shoves him away and Stefan falls off the cliff.</p>

<a href="#">10/14/2003</a>	<b>“The Woman Is A Cassadine, Which Means She’s Lethal”</b> (No Alexis or Cameron I this episode) Just a couple of Alexis mentions today from Luke and Ned.
<a href="#">10/15/2003</a>	<b>“The Brother I Knew Died A Long Time Ago”</b> Alexis and Cameron are arguing about Kristina’s daycare situation in the hall at the hospital when they come upon Nikolas and Emily who tell them that Stefan died. Alexis shows no grief and rejects the idea that the Stefan that came back to Port Charles acted like a loving brother. She tells Nikolas she won’t be going to the funeral. Cameron tells her she has to let out her grief and not keep her emotions held in like the Cassadines always seem to do. She falls into his arms in a hug.
<a href="#">10/16/2003</a>	<b>“Stefan’s Funeral”</b> Alexis arrives with Cameron and tells Nikolas she’s saying goodbye to the person that snuck her desserts and sent her to college. Helena makes an entrance and insults everyone.

<a href="#">11/05/2003</a>	<b>“I’m Dropping All Charges”</b> Alexis is angered when Cameron allows Skye to visit Kristina at the apartment. Judge Farmer tells Ned that Cameron is living with Alexis. The judge tells Ned he can have custody of Kristina if Alexis is found guilty. Alexis stands trial for fraud against Ned. Alexis butts into Dara’s cross-examination of Cindy and isn’t able to shake the girl. She tells Dara to make a deal but Scott won’t. Ned takes the stand and tells the court he’s dropping the charges against Alexis.
<a href="#">11/06/2003</a>	<b>“Sole Custody”</b> Ned drops all the charges against Alexis and she is free to go. Skye blows up at Ned and breaks up with him telling him they could have made the perfect family. Ned tells Alexis he’s signed away all parental rights to Kristina and he hopes that one day she’ll be the Alexis he once knew. Cameron arrives back at the courthouse with the baby. Seems Judge Farmer told him to surrender the child back to the court. Alexis pleads with the Judge to let her take the baby home and tells her that Ned has relinquished his rights. Judge Farmer reluctantly agrees.

<a href="#">11/11/2003</a>	<p><b>“The Ramblings Of A Shrink With A God Complex”</b>  Nikolas testifies in Luke’s murder hearing. Skye tells Alexis she should be disbarred for taking the case of the man charged with her brother’s murder. Alexis doesn’t blink. Cameron overhears Alexis’ court summation and tells her she’s going about it all wrong. Later, alone in the courtroom, Sage appears with a gun and shoots at Alexis.</p>
<a href="#">11/12/2003</a>	<p><b>“Shooting Blanks”</b>  Dillon wrestles Sage for the gun, which, it turns out, is loaded only with blanks. Lucky arrives and sees the gun and shoots Dillon . Alexis makes a statement at the PCPD and Lorenzo arrives. Alexis tells Lucky she’ll defend him if he needs it.</p>

<a href="#">11/14/2003</a>	<p><b>“John Jacks’ Funeral”</b>  As the service ends, Alexis speaks to Lady Jane and comforts Jax.</p>

<a href="#">11/18/2003</a>	<p><b>“You Shot Your Wife, Sonny”</b>  Cameron tells Sonny that Carly might not regain the emotions she had for people. He tells Sonny he’s in denial for not realizing that Carly could be changed and that he’s the cause.</p>

<a href="#">11/20/2003</a>	<p><b>“What Were The Dreams About?”</b>  Cameron has a session with Carly who tells him she dreamt she was in love with a another man and now doesn’t know how to turn off those feelings.</p>

He comments that she did some great work for Sonny and that he’s representing him now. He asks for some advice and she tells him if she were his attorney she wouldn’t help him. Nikolas and Emily arrive and Alexis hands Emily her divorce papers. She also hands Nikolas some financial statements indicating the Cassadines are close to bankruptcy. Later, at Wyndemere, Alexis tells Nikolas he’ll have to let go some of the staff and start making his own bed.</p>
<a href="#">12/10/2003</a>	<p><b>“Will You Ask Them For A Loan?”</b>  Nikolas tells Alexis he’s engaged to Emily. She warns him about the Quartermaines. She tells Nikolas his last chance to avoid bankruptcy when down with is freighter.</p>
<a href="#">12/11/2003</a>	<p><b>“We’re Broke”</b>  Alexis tells Nikolas they need to put Wyndemere up for sale.</p>

<a href="#">12/24/2003</a>	<b>“Luke’s Christmas Carol”</b> Luke is visited by the spirits of Christmas past, present and future. The spirit of the future leads him to Lucky’s grave and then the location of his own anonymous death. Alexis and Cameron both play roles. Later, a rejuvenated Luke invites Alexis and Cameron both to Christmas dinner at his house.
