01/01/2004	No episode
01/02/2004	No advance in storyline ☹
01/05/2004	No advance in storyline ☹
01/06/2004	“So I’m Going To Be A Grandfather?” At <i>The Haunted Star</i> Zander tells Cameron and Alexis that Elizabeth is pregnant with his child. He asks Alexis for legal advice. Cameron doesn’t like the advice she gives Zander. Alexis reminds him that he hasn’t been the most attentive father to Zander.
01/07/2004	No advance in storyline ☹
01/08/2004	“You Are In Serious Trouble” Nikolas is arrested for Cody’s murder.
01/09/2004	“Bail For Nikolas” Alexis manages to swing bail for Nikolas. Carly goes to Cameron and talks about her continuing fantasies about Lorenzo.
01/12/2004	No advance in storyline ☹
01/13/2004	No advance in storyline ☹
01/14/2004	“You’re Better Than This, Zander” Alexis goes to see Zander in the hospital following his provoked beating by Nikolas. Alexis tries to get him to drop the charges. Alexis tells him not to take out his anger toward Emily on Nikolas. Zander refuses to drop the charges. Meanwhile, Carly goes to see Cameron and asks to be committed to a sanitarium. Cameron says she doesn’t belong there but honors her request and takes her there.
01/15/2004	“Don’t Ever Underestimate the Truth” Alexis confronts Zander with is plan to frame Nikolas for Cody’s murder. Zander denies it. Alexis tries to get him to tell the truth and get over it but he won’t. Meanwhile, Jason tries to get Carly out of Shadybrook but Cameron stops him.
01/16/2004	“Carly May Be Hallucinating” Cameron walks into Carly’s room after she’s stabbed Jason with a hypodermic. Cameron tries to talk her down as she hallucinates about Lorenzo. Cameron goes to the penthouse and talks to Courtney about Carly’s condition. He tells Courtney that Jason was stabbed.
01/19/2004	“Just Let The Past Be The Past” Cameron tells Jason and Courtney that he saw Faith in Carly’s hospital room. Alexis gets Nikolas out of jail and tries to reason with Zander to stop his vendetta. Zander doesn’t budge. Alexis makes a deal with Ric – throw the case against Nikolas and she’ll help Ric and Elizabeth keep Zander’s baby from him.
01/20/2004	“What Do You Remember?” Cameron signs the papers to release Carly from Shadybrook. Jason and Courtney wonder about the drug she was injected with.
01/21/2004	No advance in storyline ☹
01/22/2004	“Do Me A Favor And Duck Next Time” Alexis tells Nikolas she wants to protect him. Later Alexis bumps into Jax at the hospital after he returns from treasure hunting.
01/23/2004	No advance in storyline ☹

01/26/2004	<p>“A Betrayal of Faith” (Cameron and Alexis do not appear in this episode) Faith refuses to protect Zander from Jason’s retaliation. Then Faith sells Zander out to Ric in order to save herself.</p>
01/27/2004	<p>“You Literally Just Saved My Life” (Cameron and Alexis do not appear in this episode) The police find Zander at the hospital and he runs. Maxie accidentally finds him hiding in a hospital room. Lucky arrives looking for Zander but Maxie doesn’t give him away. But she is afraid and leaves him there. Later Zander finds her outside Kelly’s and asks for her help.</p>
01/28/2004	<p>“Welcome To The Winter Informal” (Cameron and Alexis do not appear in this episode) Maxie hides Zander in her bedroom. He reminisces about a dance he went to with Emily once. Maxie is missing out on her own dance because of Zander so he has her dress up and they dance together. But he starts to feel very sad and they stop. Then Mac starts to knock at the door.</p>
01/29/2004	<p>“Everyone I Have Ever Put Myself On The Line For Has Turned On Me” (Cameron and Alexis do not appear in this episode) Maxie manages to keep Mac from discovering Zander. Zander leaves and then bumped into Emily on the docks. In desperation he asks for her help. She refuses and Nikolas arrives pushing Zander away. Zander pulls a gun on Nikolas.</p>
01/30/2004	<p>“Zander Is Shot” (Cameron and Alexis do not appear in this episode) Zander’s confrontation with Nikolas and Emily is interrupted by Jax who tackles Zander to the ground. The gun goes off and shoots Zander in the leg. He escapes and goes to the hospital where he assaults Brian in his hospital bed. Ric, meanwhile, has become suspicious of Maxie.</p>
02/02/2004	<p>“Maxie Helps Zander Escape” (Cameron and Alexis do not appear in this episode) Maxie reluctantly helps Zander escape the hospital after she’s grilled by Ric Lansing.</p>
02/03/2004	<p>“Zander Thinks You Ruined His Life” Alexis tells Cameron she’s sorry that Zander is in the trouble he’s in. Cameron catches Maxie stealing drugs to help Zander. She leads him to Zander. Cameron removes the bullet from his leg.</p>
02/04/2004	<p>“I Can’t Help My Son. Maybe You Can.” Maxie gets some food for Zander who is still in the hotel basement. Cameron asks Alexis to help Zander. She goes with Cameron to see Zander in the basement. Zander is angry and holds Maxie at gunpoint.</p>
02/05/2004	<p>“You’re All I Have Left” Alexis convinces Zander to let them help him. Maxie admits she’s been helping Zander all along and that she’s not in any danger from him. Alexis manages to cut a deal with Ric to turn Zander in. Nikolas finds Zander in the basement and they fight. Zander is knocked unconscious. Nikolas leaves him and then a fire starts in the electrical box.</p>

02/06/2004	<p>“Great. The Building Is On Fire.” Cameron is very nervous that Zander won’t make it out of the hotel alive due to Ric’s vendetta. Mac goes downstairs to arrest Zander and an explosion burns him. Maxie arrives back at the hotel and is shocked to find out that a fire started in the basement. She’s certain Zander is dead. Police and firemen start to evacuate the hotel. Alexis and Carly become trapped in an elevator.</p>
02/09/2004	<p>“Sonny Is Kristina’s Real Father” Alexis and Carly remain trapped in the elevator. The cables start to snap and the car becomes unstable. They talk about their children and Alexis tells Carly that if she dies then Kristina won’t have anyone. Carly insists that the Quartermaine’s love Kristina. Alexis tells Carly that Kristina isn’t a Quartermaine – that Sonny is her real father.</p>
02/10/2004	<p>“What Have I Done?” Carly is angry about Alexis’ confession but Alexis insists it’s true. They manage to escape from the elevator and then Alexis suddenly realizes the impact of her confession. She begs Carly not to tell Sonny. Cameron, meanwhile, comes upon Maxie outside Mac’s hospital room. She tells Cameron that Zander is dead. Alexis escapes the building while Carly remains trapped. Cameron arrives and passes Luke and Skye on his way up the stairs to find Zander.</p>
02/11/2004	<p>“All Of A Sudden, It Doesn’t Hurt So Much Anymore” Luke follows Cameron up the stairs. Cameron is distraught over Zander’s death and doesn’t care for his own life. Luke tries to get him to leave but Cameron calmly declines. A beam suddenly falls through the ceiling pinning Cameron underneath. Cameron tells Luke to take care of his children or he’ll live a life full of regret. Cameron dies and Luke gets him out of the building. Outside, Alexis sees the paramedics carry Cameron out.</p>
02/12/2004	<p>“He Sacrificed Everything For Me” Ned arrives as Alexis tells Cameron she’s sorry. Ned fears for the rest of the family when explosions rock the hotel.</p>
02/13/2004	<p>No advance in storyline ☹ I included a few standout scenes from Robyn Richards, Tony Geary and Robin Christopher</p>
02/16/2004	<p>No advance in storyline ☹</p>

02/18/2004	<p>“From Now On I’m Running This Family” Alexis arrives at Wyndemere just as Helena tells Coleman to kill Edward. Coleman leaves and Alexis explains that Helen has no business there. Alexis arrives at the hospital where Luke is waiting. They have a small memorial for Cameron. Luke tells Alexis that Cameron helped her because he was in love with her.</p>
02/19/2004	<p>“The One Good Thing In A Family Of Maggots” Alexis goes to Carly’s to make sure she didn’t tell Sonny about Kristina’s paternity. Later she finds Helena harassing Emily at Wyndemere and throws her out. Alexis tells Emily that Nikolas provided for Lesley Lu and Kristina in his will but didn’t have time to update it to include Emily. Emily reminisces about Nikolas.</p>

02/20/2004	<p>“I Knew You Were Indestructible” Nikolas returns to Wyndemere dirty but uninjured. Carly tells Alexis she’s her new attorney or else she’ll tell Sonny about Kristina.</p>
01/23/2004	No advance in storyline ☹

02/23/2004	<p>“I Intend To Win This Case” Carly blackmails Alexis into representing her. Alexis tells Carly she won’t like how she goes about the case but she better give her full cooperation. Alexis goes to Sonny and offers to make a deal for a custody agreement. He refuses and she tells him she plans to win the case and he might never get to see his kids again.</p>
02/24/2004	<p>“I’m Wasting My Time” Alexis tells Sonny she’s going to go for the jugular. Justice arrives and Alexis tells him he should advice Sonny to take the custody deal. Alexis arrives at the PCPD and tells Emily she can’t represent Nikolas because all her time will be going to Carly’s case. Alexis arrives at Carly’s and finds Lorenzo with her. She isn’t happy about it. Lorenzo leaves and Alexis tells Carly she’s going to use Sonny’s abusive childhood and emotional breakdown as weapons against him.</p>
02/25/2004	<p>“You May Be Subpoenaed” Alexis asks Courtney she will be asked to testify in Carly’s case. Courtney can’t figure out why Carly would ask Alexis to be her attorney. Jason walks in and Alexis tells they both they could be subpoenaed. Alexis goes to Carly to discuss testimonies from both Jason and Courtney. She later goes down to the PCPD to consult for Nikolas’ arraignment. Nikolas suspects her unwillingness to represent him has something to do with Kristina.</p>
02/26/2004	<p>“You And I Have A Deal” Alexis backpedals with Nikolas and tell shim she knows how Carly feels about having someone want to take her children away. Nikolas still doesn’t understand why Alexis can’t represent him. She claims conflict of interest where Zander is concerned. Alexis goes to Carly’s to discuss the case. Carly tells her that both Jason and Courtney will testify on her behalf so Alexis shouldn’t have to mudsling Sonny. Alexis tells her she can’t have her hands tied because Justus is a good lawyer and she’s going to have to pull out all the stops to get the kids.</p>
03/01/2004	No advance in storyline ☹
03/02/2004	<p>“Thank God For Estrogen” Ned runs into Alexis at the courthouse. He’s confused when she explains she’s representing Carly in the custody cast. Alexis says Carly made her do it – which makes Ned guess that Alexis is being blackmailed over Kristina’s paternity. Later, Kristina steps away as Alexis speaks to a clerk. Alexis finds her down the hall with Sonny. Sonny makes a verbal threat to Alexis.</p>
