<a href="#">03/03/2004</a>	<p><b>“I Just Called Your Bluff”</b></p> <p>Jax tells Carly that he’s going to testify to the fact that Sonny abuses women. Carly is furious and won’t let Alexis put him on the stand. Jax leaves and Alexis accuses Carly of using the custody battle to get back together with Sonny. She resigns from the case but Carly threatens to tell Sonny and Alexis backs down. Later at the courthouse, Jax asks Alexis if Carly is blackmailing her into representing her. Alexis says she is. Jax says he supports her no matter what.</p>
<a href="#">03/04/2004</a>	<p><b>“Welcome To The Sewer”</b></p> <p>Before the custody hearing Justus tries to get Alexis to compromise. She refuses. Alexis calls Ric as a witness for Carly but he ends up supporting Sonny. Carly makes a fool of herself during Ric’s testimony. Alcazar and Faith show up and make matters worse.</p>
<a href="#">03/05/2004</a>	<p><b>“You Just Caught A Break”</b></p> <p>The custody case continues with Courtney showing up late to court after having been bound and gagged. Sonny throws a fit in court because of Faith. Courtney testifies that the kids would be better off with both parents having custody. Carly is livid. Alexis calls Jason to the stand.</p>
<a href="#">03/08/2004</a>	<p><b>“12 Documented Incidences”</b></p> <p>Alexis gets Jason to testify that Sonny has a dangerous life but in the end Jason says the kids belong with both Sonny and Carly. Carly gives in to Alexis and tells her she’ll testify to Sonny’s mental breakdowns.</p>
<a href="#">03/09/2004</a>	<p><b>“Co-Freaking Dependent”</b></p> <p>Alexis gets Carly up on the stand but Carly lies after every question Alexis puts to her and refuses to make Sonny look bad. Alexis becomes furious at Carly for ruining the case but Carly tells her she still has to win it for her or she’ll tell Sony about Kristina.</p>
<a href="#">03/10/2004</a>	<p><b>“Are You Claustrophobic”</b></p> <p>Alexis serves Sam a subpoena on the docks when she’s with Sonny. Sonny tells her he once slept with Alexis. Alexis annihilates Sam on the witness stand. Justus does a fair job of working over Lorenzo on the stand as well. Then Alexis has her chance at Sonny and brings up both is claustrophobia and his child abuse.</p>
<a href="#">03/11/2004</a>	<p><b>“You Can Drop Dead”</b></p> <p>The Judge calls Carly to the stand and she says that Alexis slept with Sonny and is still in love with him. Alexis denies it. Alexis and Justus do their closing arguments and Alexis skewers Sonny. Carly maintains that if she doesn’t win then she’ll tell Sonny about Kristina. Lorenzo and Sonny both become suspicious as to why Alexis would represent someone she hates in court.</p>
<a href="#">03/12/2004</a>	<p><b>“Carly Doesn’t Have Anything On Me”</b></p> <p>Alexis and Lorenzo feel that Sonny set Carly up to intimidate her in the limo. Alexis tells Jason if Carly isn’t back in 20 minutes she’ll charge Sonny with kidnapping. Lorenzo approaches Alexis and asks her if Carly has something on her and that’s why she’s representing Carly. Alexis says she doesn’t. Carly and Sonny return and the judge speaks with both of them individually. Sonny asks Alexis how she would feel if someone tried to take her child away.</p>

<a href="#">03/15/2004</a>	<p><b>“I Don’t Give A Damn”</b> Zander visits Cameron’s grave and confesses to setting the PC Hotel fire. He tells Cameron that one day he’ll be proud of him and that he would like to name his son after him. Sonny’s limo explodes and rocks the courthouse building. Feeling guilty, Sonny gives up custody of the kids to Carly. Alexis tells Carly she doesn’t give a damn what she does anymore and that she and Sonny are the sickest couple she’s ever met.</p>

<a href="#">03/26/2004</a>	<p><b>“Nikolas’ Crash Site”</b> Alexis and Emily argue with Ross and Ric about whether or not they’re doing everything to find Nikolas. Emily finds wedding rings that Nikolas bought right before the crash.</p>

Sonny leaves and Ric tells Alexis that representing Carly after sleeping with her husband is a conflict of interest. Alexis leaves and Ric makes a call to someone asking to check up on Alexis’ relationship with Sonny.</p>

<a href="#">04/15/2004</a>	<p><b>“Our Little Girl?”</b> Alexis discusses Nikolas’ memorial service with Emily at the Quartermaine’s. On her way out, Alexis speaks with Ned. They share a tense conversation about Ned feigning father to Kristina. In the mean time, Ric’s detective has filled him in on Alexis’ employment history with Sonny – including the Christmas shootout. Ric calculates that it’s entirely possible that Sonny is Kristina’s father. Alexis walks into Kelly’s where Ric is having his meeting. Ric teases Alexis a little bit with talk about Sonny and her previous work for him.</p>

<a href="#">04/19/2004</a>	<p><b>“Nikolas’ Funeral”</b> Alexis is annoyed when Ric shows up at the funeral. She chides him about his separation from Elizabeth. Alexis gives a eulogy for Nikolas but then Helena interrupts Emily’s. Luke saves the day and throws Helena out. Ric meets with his detective but doesn’t believe his report that a D.N.A. test proved that Ned was Kristina’s father.</p>
<a href="#">04/20/2004</a>	<p><b>“Who The Hell Do You Think You Are”</b> Ric tries to get Alexis to bite by insinuates that she’s worried about repercussions if he’s prosecuted. Ric gets the lab tech at the hospital to admit that he falsified the D.N.A. test results. He tells Ric that Sonny is definitely Kristina’s father. Alexis and Carly have a run-in at the hospital. As Alexis tells Carly she’s a bad mother Sonny comes in and threatens Alexis.</p>
<a href="#">04/21/2004</a>	<p><b>“Is There A Panic Room In My Future?”</b> Ric steps in as Sonny threatens to take Kristina and give her to Ned. He asks Alexis if she wants Sonny and Carly arrested for threatening a child. Alexis just wants them to stay away from him. Ric follows Alexis to Kelly’s and tells her they have something in common – that people think they’re crazy because of mistakes they’ve made. Alexis tells him she’s not interested in becoming a part of his vendetta against Sonny. Ric suggest she take some high profile cases so that she’s too much in the eye of the press for Sonny to threaten her. She says she has a new case she’s working on. After she leaves, Ric has the prosecutor removed from that case and installs himself as prosecutor.</p>
<a href="#">04/22/2004</a>	<p><b>“I’ll be Representing Ms. Rosco”</b> Faith asks Alexis to represent her in her money laundry charge. Alexis refuses. Later Alexis has a run-in with Ric over the Sheridan case. He gets her to plea bargain but she vows to beat him in court at some point. Faith arrives at the PCPD and tells Ric she doesn’t have a lawyer yet. Alexis speaks up and says that she will be representing Faith.</p>
<a href="#">04/23/2004</a>	<p><b>“I Can’t Wait To Hand Him A Big, Fat Loss In Court”</b> Alexis goes to the Haunted Star to meet with Faith about her case. Ric arrives and tells her she built her reputation on work she did for Sonny years ago. He says she’s not nearly as good and she thinks she is. Later Alexis tells Faith she only took her case to stick it to Ric.</p>

<a href="#">05/05/2004</a>	<p><b>“You Conceited Ass”</b></p> <p>Alexis has babysitter problems and brings Kristina to the courthouse (she promptly draws on Alexis’ suit coat with marker). Ric eggs her on about beating her I court. Alexis has a brief run-in with Skye and tells her to stay away from Kristina. Alexis tells Faith she’s looking forward to beating Ric in court.</p>

<a href="#">05/11/2004</a>	<p><b>“Arrogant and Ill-Prepared”</b></p> <p>As Alexis and Ric spar over Faith’s case, Audrey calls and tells Ric that Elizabeth had a baby boy. Ric laments the fact that he and Elizabeth had planned to raise the baby together. Alexis tells him that he has to respect her decision to be a single mother. Alexis cross-examines Ned in Faith’s trial and tries to make him come across as vindictive against Sonny. She roasts him on the stand. Afterwards he tells her she’s treading on thin ice when it comes to Kristina’s paternity getting out. Ric subpoenas Sonny as a witness in Faith’s trial – only to shake up Alexis. When Ric calls him to the stand Alexis is visibly shaken.</p>
<a href="#">05/12/2004</a>	<p><b>“I’m Going to Rip You Apart”</b></p> <p>Ric gets Sonny to embarrass Alexis on the stand saying that he slept with her and since then she’s been trying to humiliate him – a woman scorned. In a recess, Alexis tells Sonny if he doesn’t back down from his initial testimony she’ll tear him apart on the stand. She tries but ends up failing. Ric’s redirect to Sonny brings Alexis to tears. Alexis blasts Ric but he responds by flirting with her and shaking her up.</p>

<a href="#">05/19/2004</a>	<p><b>“A Mating Dance”</b></p> <p>Faith teases Ric about Alexis a little bit at the PCPD. Alexis goes to Courtney and tells her if she wants her Foundation to be clean then she can’t accept any money from Sonny or Jason and she can’t have Carly involved at all. Courtney is about to argue with her about it when Jax arrives. Jax is on the board of the Foundation. Ric arrives and tells Courtney he will subpoena all the records from the Foundation so he can see if she’s laundering mob money. This irks Alexis and she goes off on him. Ric plays it cool and says she’s just flirting with him – with riles her up even more.</p>
<a href="#">05/20/2004</a>	<p><b>“Are You Taking Misogyny Classes From Sonny?”</b></p> <p>Jax tells Alexis he’s waiting for the results from Sam’s baby’s paternity test. He says he’s offered Sam money in exchange for custody of the baby. Alexis is disgusted.</p>

<a href="#">05/26/2004</a>	<p><b>“You Can Have A Career As A Novelist”</b> Alexis arrives at the PCPD to act as Luke’s defense counsel. He’s been arrested for Ross Duncan’s murder. She spars with Ric to get him released.</p>
<a href="#">05/27/2004</a>	<p><b>“Don’t Expect A Miracle”</b> Ric tries to arrest Lucky in order to keep him away from the murder investigation against Luke. Alexis gets him released but isn’t able to get Luke out on bail. Skye helps Luke escape.</p>
<a href="#">05/28/2004</a>	<p><b>“You Are Inappropriate and Disgusting”</b> Tracy brings Ric some incriminating photos of Skye with Ross Duncan’s dead body. Ric questions Skye who confesses to visiting Laura at the sanitarium. Ric concocts an entire scenario of Skye’s motive for killing Ross and show she’s trying to frame Laura for the murder so that she can claim Luke for herself.</p>
<a href="#">05/31/2004</a>	<p><b>“Are You Asking Me Out?”</b> Alexis tells Ric that any evidence he has against Skye is inadmissible because of the limitations of his search warrant. Skye thinks Alexis will try to sabotage her case because she hates her. Alexis assures her she believes Skye is innocent and doesn’t want Ric railroading an innocent person. Ric flirts with Alexis and asks her out for a drink.</p>
<a href="#">06/01/2004</a>	<p><b>“The Grazing Wino Special”</b> Alexis and Ric go to the cellar for dinner – just so Alexis can prove she’s not attracted to him. He makes fun of so-called woman like her which prompts her to act out of character – and drink a lot of wine. Ric gets the inebriated Alexis to talk about Sonny. She says she would pass on the entire relationship except for one night – the night in Puerto Rico. Ric asks Alexis to dance.</p>
<a href="#">06/02/2004</a>	<p><b>“Oh My God... He’s Got A Hickey!”</b> Alexis is awakened on the couch the next morning by a noisy Kristina. The nanny says Ric brought Alexis home drunk. He also left a message that she has to be in court by 9:00 am. She dresses hurriedly and heads to court. She’s embarrassed by her behavior – especially because she can’t remember what happened when she got home. Ric constantly flirts with her but she’s still able to get Skye off on bail. Later Alexis returns home and remembers kissing Ric on the couch.</p>
