| 06/03/2004 | No advance in storyline ☹ |
| 06/04/2004 | <p>“Will You Stop Threatening Me?”</p> <p>Jax and Courtney are hosting a charity benefit at The Cellar. Jason and Sam cause quite a stir when they arrive together and announce their engagement – and Sam’s pregnancy. Sonny and Ric have words and Alexis interrupts them. Sonny asks Alexis if Ric is trying to get any criminal information from her – if she tells anything he’ll have her disbarred. After several drinks, Ric seems annoyed that Alexis seems to be concerned about Sonny all the time.</p> |
| 06/07/2004 | <p>“Watch And Learn”</p> <p>Alexis keeps Ric from closing Courtney’s Foundation, saying she couldn’t have known that the million dollar donation from Jax was actually from Jason. Ric watch as Alexis first snuggles up to Jax and then speaks to Ned (who has noticed her hanging around Ric all night). Ric offers to take Alexis home and she accepts. They close the evening in front of her door with a kiss.</p> |
| 06/08/2004 | <p>“Sometimes You Just Got to Know The Right Buttons To Push”</p> <p>Alexis kisses Ric just to prove that she isn’t interested in him. She tells him it’s clear he has an agenda because of the way he’s acting. Later Emily arrives and tells Alexis that Nikolas is alive – he has amnesia and is living with a woman named Mary. Alexis says Nikolas must show his face before Helena tries to take over the estate. Before bed Alexis finds Ric’s keys on the floor by her door. She calls him and he has a bartender answer his phone feigning to be a woman he’s gone home with. Alexis hangs up and throws Ric’s keys out the window.</p> |
| 06/09/2004 | <p>“I Think You’re Jealous”</p> <p>Alexis arrives at the courthouse for Skye’s bail hearing and Ric immediately begins to tease her about calling him the night before. Alexis denies it. Skye arrives to court late but is pleased to find Alan and Ned supporting her. Skye receives bail in exchange for a quick court date. Ric is confident he can convict Skye and offers Alexis a deal. Skye won’t accept the deal.</p> |

| 06/16/2004 | <p>“Drunk or Sober, You Are Utterly Repugnant”</p> <p>Alexis arrives at Wyndemere and is shocked to see Nikolas there with Emily. She mistakenly calls him by his real name before Emily puts her back on track. With Nikolas out of the room Emily assures Alexis that she’s doing the right thing by not telling him who he really is. Alexis arrives at The Cellar directly behind Ric. She chides him about needing a restraining order to keep him away from her. Soon Carly arrives and she and Faith fight – leaving Faith on the ground unconscious.</p> |

| 06/17/2004 | <p>“My Stepmother Can Trump Your Mother Anytime” Faith is taken to the hospital. Ric wants to arrest Carly for assault but Alexis says a room full of witnesses will say Faith started the fight. They speak to Faith at the hospital and she refuses to press charges. Later Alexis and Ric run into each other at The Cellar. Ric talks about his mother and how she gave Ric up for Sonny. Alexis tells him she knows a little about being an unwanted child. Ric walks Alexis home through the park. Liz comes along with her baby.</p> |
| 06/18/2004 | <p>“You Named Him After His Grandfather” Liz introduces her baby Cameron to Alexis and Ric. Ric is very shaken upon seeing Elizabeth and holding the baby. When Liz leaves Ric tells Alexis than when he saw Liz and the baby he realized all he lost. Alexis tries to get him to talk but he isn't in the mood. After she leaves Liz comes back and tells Ric they shouldn't get back together.</p> |

| 06/22/2004 | <p>“Your God Complex Is Going To Crush You One Day” Ric goes to see Sonny in the hospital and wants to know who shot him.</p> |
| 06/23/2004 | No advance in storyline ☹ |
| 06/24/2004 | <p>“Yuck, Yuck And Then Yuck” Skye's trial begins with Jax on the stand. Alexis and Ric fight so much during Jax's questioning that the judge calls a recess so they can work out their differences. They stroll out onto the docks where Faith is making a deal with her new hit man. She has him fire phony shots at her to make it look as though Sonny is trying to kill her. Ric shields Alexis from the shots. Alexis says she wouldn't mind if he wanted to postpone the trial in order to investigate the shooting. He doesn't buy it. Back in court, Tracy's testimony is damaging. Ric harasses Skye on the stand so much she says she's in love with Luke.</p> |
| 06/25/2004 | <p>“I Need You To Reconsider” Alexis appeals to Lucky's better judgment and asks him to reconsider helping Skye. In the end he relents and says that his father's absence is uncharacteristic and that if he were there he'd defend Skye. Ric tells Alexis she won in court today but he'll win the jury back in the end. Skye follows a blonde woman from the courthouse to the park. She turns out to be Heather Webber. Sonny and Jason are arrested for the attempted murder of Lorenzo.</p> |
| 06/28/2004 | No advance in storyline ☹ |
| 06/29/2004 | <p>“You Were Framed” Skye's trial concludes with Alexis and Ric giving their closing statements. In the mean time, Heather goes to Skye's lake house and destroys of photo of Luke and Skye. The jury comes in unexpectedly early and delivers the verdict – Skye is guilty. As an officer takes her away, Skye sees Heather in the back of the courtroom.</p> |
| 06/30/2004 | <p>“Done Worse, Slept Better” Ric tells Skye she'll be taken to Pentonville. Alexis comes alone and tells Ric she's already filed for an appeal. She tells Skye she'll make sure she gets out of jail.</p> |

| 07/01/2004 | <p>“Holy Toledo!” After Alan, Ned, Emily and Jax speak as character witnesses on Skyes behalf, the judge sentences her to 20 years in prison. After some tearful goodbyes Skye is lead away in handcuffs. After the trial Alexis and Ric argue in the hallway at the courthouse. Sonny and Lois are sitting nearby and Lois hears Alexis comment that she slept with Sonny. Lois is shocked to hear this and embarrasses Alexis who quickly leaves. Later Alexis and Ric find themselves trapped in an elevator together after Alexis hits the stop button.</p> |
| 07/02/2004 | <p>“I’m Putting Order In Your Briefcase And Order In My Life” Alexis accidentally traps herself and Ric in an elevator together. She smashes Ric’s briefcase on the button panel and papers fly everywhere – including the results of Kristina’s D.N.A. test. In order to stop Alexis from seeing the paper, Ric grabs her and kisses her – which leads to an argument. The power comes back on but jolts Alexis into Ric’s arms just as the doors open and reporters see them. They question if they’ve been having an affair during Skye’s trial. Later, Alexis and Kristina see Ric at the hospital. Kristina wanders off and manages to find Sonny by the baby nursery – much to Alexis’ dismay.</p> |
| 07/05/2004 | <p>“You’re Working For Lorenzo Alcazar?” Alexis retrieves Kristina from Sonny and then leaves. Ric confronts Sonny, Faith and Lorenzo about Nico’s suspicious death. Alexis runs into Nikolas on the docks (he still thinks he’s Conner Bishop). He says that he found out that Emily has known him for a long time and that he’s now working for Lorenzo.</p> |

| 07/08/2004 | <p>“I Wanted To Tell You The Truth” Ric goes looking for Sam who is wanted for murder in South Carolina. Turns out “Sam” is an alias. Alexis runs into an angry Nikolas. Although he can’t remember it, he knows he’s really Nikolas Cassadine. Nikolas is mad at everyone from his former life and tells Alexis he’s now working for Lorenzo Alcazar. Alexis warns him that Lorenzo is dangerous. Alexis runs into Ric on the docks and tells him to go after Lorenzo. She feels he has an agenda and will use Nikolas.</p> |
| 07/09/2004 | <p>“You Tell Me Where Sam Is” (No Alexis today) Ric goes to Sonny to find out where Jason is hiding Sam. Sonny leave and Ric tells Carly he knows she was the one that told the police in North Carolina where Sam was hiding.</p> |
| 07/12/2004 | No advance in storyline ☹ |
| 07/13/2004 | <p>“For Once We’re Working Together” (No Alexis today) Sonny tells Ric that Jason and Sam are unreliable. He wants Sam away from Jason because she’s a bad influence. He offers to find out where Sam is for Ric.</p> |
| 07/14/2004 | <p>“That Woman Was So Filled With Grace” Alexis finds out from Nikolas that Lila Quartermaine has died.</p> |

| 07/15/2004 | “I Thank You Just This Once” Rick offers to delay their case so Alexis can be with the Quartermaines. She has no intention of doing so. Rick admonishes her about not letting Kristina know her own family. Later Alexis relents and tells Rick he was right. She’s decided to go spend some time with the Quartermaines. |
| 07/16/2004 | “Lila Quartermaine’s Funeral” Eulogies from her family, a song by Brooke Lynne and a montage about Lila’s life. |
| 07/19/2004 | No advance in storyline ☹ |
| 07/20/2004 | No advance in storyline ☹ |
| 07/21/2004 | “Would You Consider Having Dinner With Me Sometime?” Alexis tells Nikolas about his old self – about Laura, Stefan and the family legacy. Ric goes to Sonny’s looking for Sam once again. Later in the park Ric taunts Carly about Sam having Sonny’s baby. Alexis approaches Ric after he calls for more surveillance on Sonny. She tells him that his vendetta is going to far. He argues but they stop fighting. Ric asks Alexis if she’d like to go out to dinner with him. |
| 07/22/2004 | “Please Don’t Tell Him” Ric brings Sam to the PCPD and tells her she’ll be having her baby in jail in North Carolina. She tells him the baby is Sonny’s. Sonny and Justus arrive. After Justus speaks to Sam he tells Sonny he can’t take the case – he recommends Alexis. Carly goes to Alexis and tells her she’s going to tell Sonny about Kristina. Alexis begs her not to and appeals to her sense of motherhood. Later, Sonny arrives at Alexis’ doorstep. |
