07/23/2004	<p>“You Came Here To Hire Me?”</p> <p>Much to Alexis’ relief, Sonny is only there to convince her to defend Sam in her murder trial. Alexis doesn’t think she can help but Sonny manages to persuade her. Meanwhile, Ric tells Sam Sonny is only interested in her baby – not her. Alexis and Sonny arrive. Alexis tells Ric he better get used to losing.</p>
07/26/2004	<p>“Servicing His Megalomania”</p> <p>Ric tells Alexis that Sam’s extradition hearing will be held that night. Alexis asks the judge for more time to review the case. He denies it. Ric tells the judge Alexis is only trying for more time because she wants to be near him. Alexis objects and the judge tells them if they want to act like this they should get a motel room. Alexis is horrified. Sam asks Alexis to call Sonny but Alexis won’t. She tells Sam that Sonny will only care for the baby and not her. She explains his sick break-up pattern with Carly. Later Ric tells Alexis he asked the judge to delay the extradition but he wouldn’t do it. Alexis is disgusted with him and leaves.</p>
07/27/2004	<p>“I Intend To Win”</p> <p>Sam is rushed to General Hospital with abdominal pains. Ric tells the doctor to take her time and make sure she checks her out thoroughly. Alexis thinks he’s up to something. Sam tells Sonny that she’s faking. Alexis asks Carly not to tell Sonny about Kristina. Sonny threatens to beat Ric up.</p>
07/28/2004	<p>“What You Did To Carly Was Psychotic”</p> <p>Carly tries to get Sam to confess to the fire but she won’t. Ric walks in and tells Sam he’ll try to keep her in P.C. instead of being extradited. Carly tells Ric that Sam is just a pawn in his quest to ruin Sonny’s life. Ric says Sonny should be made to answer for his crimes. Ric says he’s changed. Alexis enters the conversation and Carly leaves. Alexis tells him that what he did to Carly was nuts. Ric says he’s a rational human being and did what he did to Carly out of grief of losing his own child. Ric talks to Lucky and Emily about Jax’s shooting and feels they’re keeping something from him. He then finds Courtney and starts to talk to her about the shooting.</p>
07/29/2004	<p>“I Don’t Care To Rehash That Disgusting Event”</p> <p>Alexis warns Sam that Sonny may feel he can have custody of their child if he helps her. Sam says she wants Sonny to have custody. Alexis warns her of his dangerous life but she isn’t willing to listen. Ric tries to get Courtney to tell him who shot Jax but she isn’t talking. She gets support from Sonny when he arrives. Later Alexis and Ric meet up in the hallway and argue about her being attracted to him. She starts to hyperventilate and leaves. As Ric and Sonny argue about Sam’s case Alexis comes and tells them that a death row inmate has confessed to the fire. Ric is sure that Sonny arranged the whole thing.</p>

07/30/2004	<p>“Sonny Gave Me His Word”</p> <p>Ric tries to get Carly to help him put Sam in prison. He tells her it would be better to get rid of Sam so she can have Sonny all to herself. Meanwhile, Sonny runs into little Kristina at Kelly’s where the nanny is buying some cookies. Alexis comes by and is alarmed to see them together. Alexis asks Sonny if he’s responsible for the death row inmates sudden confession. He tells her he had nothing to do with it. Carly agrees to help Ric put Sam in jail. Alexis tells Ric that Sonny gave his word that he didn’t arrange the confession. Ric is infuriated that she would trust Sonny. Carly shows up at the courthouse with a tape for Ric to listen to. It’s Sam eluding to the fact that the death row inmate is lying. Later Ric tells Alexis to resign from the case or she’ll go down with Sonny.</p>
08/02/2004	<p>“I Want To Help You Take Sonny Down”</p> <p>Alexis tells Ric to admit that Sam’s case is over. Ric insists that Sonny set up the confession. Alexis tells him to quit the vendetta against Sonny. Alexis is successful at the hearing and Sam’s verdict is vacated. Afterward Alexis overhears Sonny and Carly talking about arranging the confession. She goes back to Ric and tells him she wants to help him nail Sonny.</p>
08/03/2004	<p>“I’m Going To Help You Send Him To Prison”</p> <p>Alexis tells Ric she wants to help him put Sonny in prison for good. She tells Ric about the conversation she heard. Ric overhears Lucky tell Emily that Jason has been hiding Sam’s brother. Ric tells Alexis about the brother. They figure he must be connected to the murder. Ric finds Sam’s brother. Meanwhile Alexis is on the phone with someone trying to find out if Sonny or Jason has visited the Texas inmate. As she finishes her call Sonny walks in.</p>
08/04/2004	<p>“If You Put Me On That Stand, I Will Deny Everything”</p> <p>Ric questions Danny about the fire but he says Sam told him never to speak of it. Sonny asks Alexis if she and Ric are dating. He questions why she’s in Ric’s office. Alexis says she’s there to gloat about her win in court. Ric arrives and covers for her by acting rude. Ric asks Sonny why he’s there. Sonny tells him to lay off his kids and their mothers. Ric asks Alexis if she’s still going to help. She says she is. Ric tells her he thinks he can get Sonny on perjury. Sonny tells Jason he thinks Alexis knows he was lying and she’s teamed up with Ric. Ric tells Alexis she could be a witness in the perjury case. Alexis gets enraged and says she’ll never testify. Ric asks why. Alexis says she’s got a daughter to think of. She starts to hyperventilate in fear and Ric tells her he won’t ask her to testify. She’s not sure she believes him. Ric tells her that if Sonny ever reached out to him he’d be happy.</p>
08/05/2004	<p>“I Know All About Your Brother”</p> <p>An officer tells Ric that Danny is missing. Ric goes to Sam and tells her he knows all about her brother. He says the Texas inmate was paid off by Sonny and that he knows Danny knows what happened and he’ll put him on the stand. He orders Sam to tell him where Danny is hiding. She refuses. Later Sam arrives at the PCPD and confesses to her mother’s murder.</p>

08/06/2004	<p>“Confessions and Threats” Sam confesses to her mother’s murder and then Ric tells her he’s going to call her brother in as a witness. Alexis assures her that Ric can do it if he wants to. Sam makes a full phony confession on tape. Sonny arrives and Ric says he has Sam’s full confession. Sonny asks Ric to do him a favor and come with him. Ric isn’t sure but decides to go. They arrive at the safe house and speak to Danny. Danny tells the story of the fire and how he accidentally knocked over some candles and set the fire. Ric admits that he has to drop the charges against Sam. Meanwhile, Carly has arrived at the PCPD and threatens Alexis.</p>
08/09/2004	<p>“I’m Sick To Death Of You” After initially telling Carly to go ahead and tell Sonny about Kristina, Alexis relents and agrees to try to keep Sonny out of jail for perjury. Ric decides not to charge either Sam or Danny but is determined to get Sonny in jail one way or another. He thinks Faith’s murder is just the ticket. Sonny asks Alexis to represent Jason and Max when they’re arrested for the explosion on Lorenzo’s yacht. Alexis tells Sonny off in no uncertain terms just before Faith arrives at the PCPD.</p>
08/10/2004	<p>“I’m Marginally Impressed” Faith appears at the PCPD and says that both Sonny and Lorenzo conspired to kill her. She had to blow up the yacht in order to escape. Ric angrily tells Lorenzo that he’ll deal with his brother himself next time. Alexis hears this exchange and accuses Ric of waiting for a murder instead of preventing it. He said he had no idea that Faith would try to blow up the yacht. She asks him how many people will be hurt because of his vendetta against Sonny. Later Alexis returns and tells Ric she might have spoken hastily. She says she admires him for being the only person willing to take on Sonny. She turns to leave and drops her briefcase. As part of a montage, Ric helps Alexis pick up her things and then kisses her.</p>
08/11/2004	<p>“I Wouldn’t Mind Getting You Drunk” Ric runs into Alexis outside Kelly’s and says he was about to call her. She makes fun of that old line and tries to indicate that he’s just like every other man that doesn’t call. He tells her he wanted to call her about Skye’s appeal. She’s surprised. Ric then tells her she should drink more because she loosens up. He says he’d like to take her out for dinner and dancing some time but it’s up to her to call him.</p>
08/12/2004	<p>No advance in storyline ☹</p>
08/13/2004	<p>“Maybe Sonny Deserves Everything That Ric Is Throwing At Him” Justus resigns from being Sonny’s attorney after Sonny tries to get him to quit as Faith’s attorney. Alexis and Emily meet with Helena who has committed Nikolas to an institution. Justus warns Justus that Sonny will be angry that he quit as his attorney. Alexis walks in and says that Sonny deserves to be punished.</p>

08/16/2004	<p>“You’re A Monster”</p> <p>Alexis is astonished at Sonny’s lack of humanity when Faith is knifed. She leaves and Sonny comments to Ric that he cares nothing about Alexis. He says Ric is pathetic for going after one of his one night stands. Alexis finds Carly outside Kelly’s talking to Kristina. Alexis tells her to stay away from Kristina. Carly says Alexis should be grateful. Sonny comes along and hears them. Alexis says she paid of her debt to Carly by representing her in court. Viola comes out with Kristina and Sonny chats with her and tells Carly she’s cute. Alexis arrives at the PCPD. Ric says Faith’s wounds are superficial. He says it’s going to be hard to prove Sonny murdered Faith if he tries. He says Sonny will make a mistake one day. Alexis tells him she might be able to help him out since she represented Sonny for 2 years. Alexis brings Kristina to her doctor’s appointment. Carly tells Sonny she wants to look for her father. Ric comes along and asks Sonny how many kids he has now.</p>
08/17/2004	<p>“French Fries and an Invitation”</p> <p>Ric tells Sonny and Carly that their kids are constantly in danger because of Sonny’s life. Sonny and Carly argue with him and leave. Alexis hears the end of their conversation. She and Kristina have dinner with inside Kelly’s. Ric feeds Kristina French fries. They talk about Sonny’s children being in danger. Ric tells Alexis she’s a great mom and Kristina is a wonderful child. Alexis invites Ric to Kristina’s gymnastics class.</p>
08/18/2004	No advance in storyline ☹
08/19/2004	<p>“So You Were Married To Jasper Jacks?”</p> <p>Ric stops Mac from putting out an A.P.B. on Faith . He wants to catch Sonny in the act of trying to kill her. Alexis goes to the docks and warns Justus that it’s a bad idea to represent Faith. Alexis invites Ric to Kelly’s to talk about Skye’s appeal. A commotion ensues when Courtney and Jax arrive. Mike doesn’t approve of Jax dating his daughter. Alexis explains her marriage of convenience to Ric. Alexis tells Jax to be sure he likes Courtney for the right reasons – not just because she’s Sonny’s sister.</p>

After Alexis arrives Ric tape records Nikolas’ and Emily’s story about what happened. Lorenzo arrives a the PCPD and attacks Ric when he finds out Sage had been held in the Quartermaine freezer. Lois takes him away to cool down. Later Alexis expresses her concern to Ric that he might be on the top of Lorenzo’s revenge list.</p>

09/01/2004	<p>“Doesn’t Mean I Can’t Thank You” Alexis argues with Ric about Nikolas’ case. She says it’s clear Nikolas didn’t premeditate shooting Mary – he honestly thought he was protecting Emily. She asks him as a personal favor to drop the charges. Later Nikolas is released with lesser charges and Alexis thanks Ric.</p>
09/02/2004	<p>“You Need Me... A Hell Of A Lot More Than I Need You” Ric tells Sonny that Justus has “switched sides” and is helping Faith escape. Sonny seems unconcerned. Ric says he just wants to find Faith and asks for Sonny’s help. He’s unwilling.</p>
09/03/2004	<p>“A Plea of Insanity” Lucky and Ric go to see Mary. Ric tells her that her husband is dead. She starts to freak out. Lucky tells Ric that Mary is faking it.</p>
09/06/2004	<p>No show due to Labor Day</p>
09/07/2004	<p>“My Big Brother Finally Came Through” Sonny tries to get Justus to kill Faith. Ric comes along and tells Faith that Sonny clued him in on her hideout. He arrests both Faith and Justus. At the PCPD Faith claims Justus was her hostage and she made him help her escape. Must to Jason’s dismay Ric has to let Justus free. Ric tells Justus he’ll ensure his safety if he helps him nail Sonny. Justus refuses.</p>
09/08/2004	<p>“You’ll Take Any Case So That You Can Be Close To Me” Alexis runs into Ric at the courthouse and he suggests that she have a passionate affair with someone she works with. She says she’s never even considered it. Ric has a judge throw Justus off Faith’s case for conflict of interest so Justus asks Alexis to take on the case. She’s reluctant, considering Faith is being charged with shooting Jax. In the end she takes the case and then teases Ric about beating him in court. Justus tells Faith that Alexis is her new attorney. She isn’t thrilled.</p>
09/09/2004	<p>“That Is Breathtakingly Narcissistic” Jason tries to get Justus to take Emily’s case by threatening him. Then he threatens Ric if he prosecutes her. Alexis warns Ric that Jason won’t let up on him.</p>
09/10/2004	<p>“You May Want To Call An Attorney” Ric questions Emily about Mary’s death. Emily lies, which prompts Ric to question Elizabeth.</p>
09/13/2004	<p>“That Would Be Your Cue To Leave” Alexis expresses concern for Kristina who has had a few fevers of late. She tells Ric the doctor wants a follow up visit with her. As they are speaking Helena strolls in and demands Nikolas be put back in Shadybrook. Ric tells her that a judge revoked her commitment papers and Nikolas is free. Helena is livid. Alexis tells her that Nikolas won’t go to jail – Helena isn’t happy about that either. When Helena leaves Ric and Alexis argue over Nikolas’ case.</p>

09/14/2004	<p>“Must You Always Throw That In My Face?”</p> <p>Alexis tries to convince Ric to look at Alcazar as a suspect in Mary’s murder. Ric recalls that she tried to get him to arrest Lorenzo before when he was getting too close to Nikolas. He warns her people will think she has a vendetta. Lorenzo arrives at the station to be questioned but is followed by a whirlwind Lois who disrupts the meeting. Lorenzo ends up leaving. Later Ric meets Stephan Lars in the squad room – he says he’s working for the Justice Department.</p>
09/15/2004	<p>“If You’re Going To Kiss Me Again, I Think We Should Discuss It First”</p> <p>Alexis finds Jason and Sam at the hospital and informs Jason she’ll be calling him as a witness in Faith’s trial. Sam goes off on her saying she’s obsessed with Sonny and calling Jason is just a way to get close to him. Alexis picks up Kristina from the doctor after learning some bad news. Steven Lars introduces himself to Ric and asks for a job. Ric isn’t interested – especially when he makes the connection that Stevan is Liz’s brother. After Steven leaves, John Durant calls Ric and encourages him to take advantage of Steven’s talents. Ric declines. Alexis arrives at Ric’s office for a meeting – not realizing that the meeting is for next week. Alexis is in a horrible mood and Ric asks her what’s wrong. She tells him Kristina needs glasses. She’s afraid she’ll be picked on by other kids. She says intelligent women are always picked on. Ric says he thinks intelligent women are sexy. Alexis becomes uncomfortable and stands up. Ric follows her and gets closer and closer and then finally kisses her. They frantically paw at each other and make out on the desk. Then John Durant walks in and catches them.</p>
