03/01/2005	<p>“I’m Going With You” Ric tells Elizabeth that Faith was the one that pushed her down the stairs causing her miscarriage – not Sonny. John tells Ric that Faith has been found and shot but that they don’t know where the kids are yet. Ric tells Alexis and she insists on going to Louisiana with Ric. He agrees she should. Dr. Meadows says it’s okay if she goes as long as she’s careful.</p>
03/02/2005	<p>“My Sweet Baby” Ric and Alexis arrive in Louisiana where everyone is worried that Michael was killed. Alexis comforts Carly and tells her Michael did a brave thing by staying to protect his sister and brother. The F.B.I. tracks the kids and Kristina is finally reunited with Alexis at the airport. Michael is still nowhere to be found.</p>
03/03/2005	<p>“A Clean Bill Of Health” Kristina is given a clean bill of health. Elizabeth congratulates Alexis on her pregnancy. Emily comes to visit Kristina and tells Emily that Michael could be dead. Jason and Ric try to prevent Sonny from killing Faith in the hospital. Ric tells Alexis they have to move on with their lives while hoping for Michael’s return. He says the four of them can go home now. Lorenzo tells Reese and Ric that Faith said she killed Michael and dumped his body in the swamp.</p>
03/04/2005	<p>“Whatever You Need. I’m Your Friend” Skye tells Ric and Reese that she was the one that helped Faith escape in return for confessing to Ross Duncan’s murder. Despite her denials, both Ric and Reese feel that Luke was her accomplice. Jax asks Alexis to represent Courtney for charges that she murdered A.J. In a nice family moment, Alexis and Kristina go to Ric’s office to visit.</p>
03/07/2005	<p>“We’ve Been Through Too Much Together” Ric confronts Faith in her hospital room. He tries to get her to name her accomplice. Faith says Ric is a hypocrite for prosecuting her considering how he kidnapped Carly. She says if he doesn’t allow her to plea insanity then she’ll ruin his life, career and marriage. Ric refuses to cut any deal with her. Faith says she’ll just tell the court that she did it to get back at Ric for treating her like garbage. Alexis walks in and says Faith can’t destroy her marriage. At the courthouse, Faith pleads not guilty and then is shot outside the courtroom .</p>
03/08/2005	<p>“I Would Not Change What We Have Together” Alexis goes to the hospital to check on the baby. Elizabeth tells Alexis that when Faith pushed her down the stairs and cause the miscarriage it also caused the end of her marriage to Ric. Elizabeth says the miscarriage pushed Ric over the edge and he had a break down. Alexis asks Ric if it weren’t for the miscarriage would he still be with Elizabeth. Ric says he loved Elizabeth very much but that he wouldn’t change anything about he life he has with Alexis for anything or anyone.</p>
03/09/2005	<p>“Lorenzo Is Arrested” Reese arrests Lorenzo for being Faith’s accomplice.</p>

03/10/2005	<p>“I Wouldn’t Want This For Anybody” Emily takes Alexis home from the hospital. Alexis tells her she’s concerned that she’s wearing herself out. Emily says she’s afraid that Nikolas won’t be the same when he gets out of prison. Ric releases Lorenzo. Sonny and Carly see a picture of “dead” Michael. Ric goes home and tells Alexis that Michael is dead.</p>
03/11/2005	<p>“He Got To You” Reese tells Ric the F.B.I. has closed the case and she’s headed back to D.C. – even though she isn’t satisfied the case is completely solved. Ric senses she feels something more for Sonny.</p>
03/14/2005	<p>“More Than Enough” In the aftermath of Michael’s “death”, Ric and Alexis bring Kristina to see Sonny. He tells Kristina that Michael is living in heaven. Ric and Alexis attend Michael’s funeral.</p>
03/15/2005	No advance in storyline ☹

03/18/2005	<p>“Fasten Your Seatbelt” Ric and Alexis go to Alexis’ ob/gyn appointment together. As they leave they come upon Elizabeth who is concerned about Emily. Liz tells Alexis that Ric used to do spontaneous romantic things with her – which gives Alexis a bright idea. She has Ric drive out to a secluded location where she seduces him in the car. But the frolic is short-lived when their car is hit by another.</p>
03/21/2005	<p>“You’re Going To Be Alright” Ric manages to pull both himself and an unconscious Alexis from the wrecked car. He’s unable, however, to call for help because his cell phone is out of range of a tower.</p>
03/22/2005	<p>“I Love You” Ric and Alexis are rescued by Dillon and Georgie. At the hospital, Alexis remains unconscious for awhile. During that time Ric sits at Alexis’ bedside and tells her that he loves her and needs her. Alexis regains consciousness in time for Monica to tell them that Alexis has a heart murmur. Alexis calls home to say goodnight to Kristina and discovers that Sonny has her. She’s livid but Ric tells her to let Kristina stay there the night and they’ll get her in the morning. Ric leaves and Alexis finds her way to Sonny’s.</p>

03/23/2005	<p>“I’m Not A Broodmare” Alexis argues with Sonny about Kristina staying at his house – a house that Kristina was taken from. She tries to get Carly to agree with her to no avail. Ric arrives and demands she return to the hospital and leave Kristina there for the night. Alexis and Ric go to the hospital and have a bitter fight. Ric ends up leaving her alone believing she can’t love him as he loves her.</p>
03/24/2005	<p>“I Miss Being Home” Ric takes Kristina to the hospital to see Alexis. They refrain from arguing too much while Kristina is in the room. Alexis tells Ric she’ll do whatever it takes to protect her. Reese asks Ric to ask Sonny not to retaliate against the Sandovals. Ric refuses saying Sonny won’t change and can’t be saved. Later he asks Lorenzo to leave town and warn Sandoval.</p>
03/25/2005	<p>“Playground Memorial” Despite Alexis’ objections, Ric takes Kristina to the dedication of a memorial playground for Michael. While at the dedication, Sonny’s men murder members of the Sandoval crime family.</p>
03/28/2005	<p>“Primary Custody Is Not Nearly Good Enough” At the playground dedication, word comes in that the Sandoval family has been massacred. Alexis takes Kristina home while John and Ric talk to Sonny. When Alexis returns she yells at Ric for bringing Kristina to the park when he knew there would be mod activity. Ric goes to Sonny’s and asks him to back off on the visits with Kristina – to give Alexis a break. Sonny tells Ric that the hit today will make Kristina much safer.</p>
03/29/2005	<p>“I Rest My Case” Ric finds Alexis taking photos of the crime scene. She says she’ll use them when she goes to court for full custody. Ric tries to talk her out of it and Alexis can’t understand why he’s suddenly on Sonny’s side instead of hers. They each state their case but reach in impasse. Alexis leaves. Ric, meanwhile, runs into Elizabeth at the hospital and vents to Elizabeth. Alexis arrives and then leaves after seeing that Elizabeth doesn’t exactly share her opinion. Alexis contacts Dara and asks her to represent her against Sonny.</p>
03/30/2005	<p>No advance in storyline ☹</p>
03/31/2005	<p>“I Am Committed To Our Marriage” Dara has the court papers drawn up for Alexis. She says it will strengthen Alexis’ case if Ric signs the petition as well. Ric, meanwhile, goes to Sonny and begs him to back off a little. He says if he doesn’t give Alexis room she’ll try to get full custody and probably get it. Sonny says nothing will keep him from Kristina. Alexis asks Ric to sign the petition and he says he can’t. He says he doesn’t feel Alexis can win yet. Alan steps up to them and confesses to being the one to hit them with his car. Ric tells Alexis that since she can no longer use the accident against Sonny she should back off. She says there are plenty other reasons she can bring up in court to keep Kristina from Sonny. Ric says he’s committed to their marriage and doesn’t understand why Alexis wants to start another fight with Sonny. He says that Sonny will come after her with everything he’s got and it’s not worth the risk to their family. He says the custody judge won’t look kindly on her bringing this petition right after Sonny’s child died.</p>

04/01/2005	<p>“I Don’t Give A Damn”</p> <p>Ric feels that Alexis’ custody battle is an exercise in futility and he can’t be a part of it. Alexis asks Ric not to abandon her and Kristina. Ric says he’s trying to make sure she doesn’t make a terrible mistake that could destroy everything. She says she’ll never forgive herself if she doesn’t try. Ric begs her to drop the suit but she refuses. Dara goes to Sonny’s and gives him a copy of the custody petition. She tells him that Michaels death will figure prominently in the judge’s decision about custody. Until the decision Sonny’s rights to see Kristina have been suspended. Sonny is furious. Ric arrives at Sonny’s and tells him he tried to get Alexis to drop the custody case. Ric begs Sonny not to make a bad situation worse. Sonny goes to Metro Court and calls Alexis a bitch. The court appointed psychologist hears the whole conversation.</p>
04/04/2005	<p>“No Help From Reese”</p> <p>Sonny tells Dr. Winters that nobody will keep him from Kristina. Sonny calls Ric to his house and tells him he’ll break Alexis and do whatever it takes to get sole custody. He threatens to make sure Alexis never sees Kristina again. Reese walks in and Ric figures Sonny has her on his side for the custody issue. Carly rags on Alexis about trying to take Kristina away after Michael died. Alexis asks for Reese’s help but Reese refuses.</p>
04/05/2005	<p>“I Am Denying Your Petition”</p> <p>Both Alexis and Sonny meet with the court-appointed psychiatrist and then with the judge. Although the judge says he wouldn’t let his kids near Sonny, he can’t go against the law. He says Alexis has no more evidence against Sonny than the last hearing so he can’t change the custody arrangements.</p>
04/06/2005	<p>“Why Won’t Anybody Hear Me?”</p> <p>Alexis tells Ric that she’s going to start seeing a therapist because she needs help dealing with her life. Ric doesn’t believe her – especially when she reveals that the doctor she’s seeing is the court-appointed psychiatrist. Alexis goes to see a person we cannot see and asks for help. Later at home, Alexis and Ric make out on the couch.</p>
